#### Navajo Nation Chapter Summit

On November 2, 2018, the New Mexico Indian Affairs Department was invited to present on the Capital Outlay and Tribal Infrastructure Fund process and applications for the Navajo Nation Chapter Summit in Albuquerque, New Mexico. The presentations covered the process for Capital Outlay for the upcoming 2019 legislative session and TIF portal process. The TIF presentation covered the TIF portal and how to create an account and username, and the steps in applying for TIF funds.



#### Native American Veterans Health and Wellness Symposium

On Friday, November 9, 2018, Jolene Catron, IAD Management Analyst, and Acting IAD Secretary Suzette A. Shije, both veterans of the U.S. Marine Corps, attended the Native American Veterans Health and Wellness Symposium, hosted by the Pueblo of Isleta Veterans Association, the Indian Health Service, New Mexico Veterans Administration Health Care System, and the AARP New Mexico. The one-day event provided an opportunity for all veterans to network, learn about federal and state veterans' services and have one-to-one discussions with those professionals who oversee veterans' programs or are available to answer questions that a veteran might have. The IAD representatives attended sessions on health services through the Raymond G. Murphy VA Medical Center in Albuquerque, VA housing programs, and behavioral health programs. A traditional color guard from the Pueblo of Taos brought in the colors to start the event, and a delicious lunch was provided to a full house of veterans and their families.

#### **Littlewater Chapter Site Visit**

IAD staff were invited to attend the Littlewater Chapter Heart Butte "Meter Installation" in Littlewater, New Mexico on November 7, 2018. The event commenced with a Navajo Blessing Way Ceremony by Navajo medicine man Johnny Perry and attended by local community leaders, family, friends and relatives. Continental Divide Electric Company installed the meter and turned on the electricity for Clintus and Bertha Muskett who waited for thirty (30) years. The Indian Affairs Department also attended three (3) other homes who received electricity and the homeowners were appreciative of the TIF funding for the powerline extension project.



#### **Drought Task Force Meeting**

Lawrence John, Tribal Infrastructure Fund Administrator attended the New Mexico Drought Task Force meeting at the New Mexico State Capitol. Chairman Tom Blaine opened the meeting. Mike Hamman, MRFCD, CEO and Chief Engineer, provided an update on the MRFCD and Drought. Royce Fontenot, National Weather Service provide an update on current conditions and forecasts and activities of the Monitoring Work Group. Sam Fernald, WRRI Director, provide a report on the 2018 New Mexico Drought Plan. One action was brought before the Task Force which is to approve the NM Drought Plan or vote to give the Drought Task Force Chairman authority to approve the Drought Plan. A motion and second was made to table the Drought Plan and provide the Task Force an opportunity to review and make recommendations.

The next meeting is planned for December 17, 2018 at the State Capitol, Room 311.

#### Navajo Nation Reconciliation Meeting

On November 14, 2018 the Navajo Nation Reconciliation meeting was held at the Alamo Chapter, Alamo, New Mexico. The Indian Affairs Department met with the Navajo Nation Capital Projects Management Department. A total of fifty-three (53) capital outlay projects and sixteen (16) tribal infrastructure funds projects were reconciled with the Navajo Nation. Each project supervisor provided an update on when Notice of Obligations will be requested from the Navajo Nation and Request for Payments will be submitted for reimbursement.



#### **Sub-Committee Indian Affairs Committee**

The Indian Affairs Department Acting Cabinet Secretary Suzette A. Shije, and Lawrence John, Tribal Infrastructure Fund Administrator attended and presented before the Sub Committee of the Indian Affairs Committee at the Picuris Pueblo Tribal Administration, Picuris, New Mexico on November 26, 2018. IAD presented on the on program priorities, and overview of the Capital Outlay and Tribal Infrastructure Fund projects balances and expenditures from FY15 to FY18.

#### Santo Domingo Health Center Groundbreaking Ceremony

On November 30, 2018, Lawrence John, Tribal Infrastructure Fund Administrator, attended the groundbreaking ceremony for the Pueblo of Santo Domingo Health Center. Poqueen Rivera, Representative of Congresswoman Michelle Lujan Grisham, Michelle Kavanaugh, Representative of U.S. Senator Tom Udall and Dr. Leonard Thomas, Director, Albuquerque Area Indian Health Services, Governor Thomas Moquino, Jr. and Lt. Governor Sidelio Tenorio, Sr., provided remarks of support and thanked all those involved in the project for the new health center for the Pueblo of Santo Domingo

## <u>First in Nation, Tribal Partnership Program</u> <u>Watershed Management Plan</u>

IAD staff were invited to attend the signing of the First in the Nation, Tribal Partnership Program Watershed Management Plan (Section 203 of the Water Resources 23Development Resource Act of 2000, as amended). The signing took place at the Pueblo of Santa Clara and the U.S. Army Corps of Engineers Partnership Celebration meeting that was held on Friday, November 30, 2018 at the Santa Claran Hotel Event Center in Espanola, NM. Attendees were provided with remarks from Governor Chavarria, Pueblo of Santa Clara, Dr. Ron Kneebone, United States Army Corp Engineers Director, and the SPD and SPA Commanders. The signing of the Proclamation was done by James Naranjo, Pueblo of Santa Clara Lt. Governor, Michael Chavarria, Pueblo of Santa Clara Governor, and the SPD and SPA Commanders.

The portal training provided an overview of the TIF requirements, information on how Critical Need, Project Readiness, Leveraging, Supporting Documents, Submitting the TIF Application, how to create an account, logging on, and tribe & project information.
