Senate Bill 13 establishes an annual event to support New Mexicans with missing relatives by bringing together federal, state, local and tribal law enforcement and partners to one location to assist families with filing and updating missing person reports, submitting DNA records to the National Missing and Unidentified Persons System (NamUs), and providing opportunities to meet with an investigator to discuss their relatives case. A network of services will be offered to families to help them distribute information to media outlets about their missing relatives case. Healing services such as support groups, onsite counseling, traditional healers, and victim

advocates will also be available.

This Annual Event will:

- 1) Support families to elevate their loved one's case and promote public awareness.
- 2) Elevate the visibility of missing persons cases across our state during the annual event and throughout the year.

According to our state's Missing Persons Clearinghouse, as of February 1, 2022, there are 926 active missing persons and 20 unidentified persons reported across New Mexico in the National Crime Information Center (NCIC).

- **3) Require** the Department of Public Safety's Missing Persons Clearinghouse to host this event in collaboration with the National Missing and Unidentified Persons System, the NM MMIWR Task Force, and other state, federal, tribal and local partners.
- 4) Collect DNA, dental records, fingerprints, photographs and other identifying information to complete the NamUs profile to improve the likelihood that the missing person may be located or identified.
- **5) Educate** New Mexicans about missing persons in our state, what they can do to help, and challenges associated with missing persons cases.





The Missing and Murdered Indigenous Women and Relatives Task Force has developed this proposal with guidance from agencies hosting similar events, the NamUs Regional Program Specialist, and the Department of Public Safety.
